

IOWA STATE TRAPSHOOTING ASSOCIATION

Annual Membership Meeting

July 26, 2014

President Denny Dozark called the 2014 Annual Membership Meeting to order at 8:00 a.m. on Sunday, July 26, 2014, at the ISTA Home Grounds in Cedar Falls with 94 members in attendance. Director's Don Wickliff, Jim Cole, Jon Peterson and Kevin Hartwig were present, as well as the Alternate Directors Steve Glasgow, Dave Wickman, Doug Brower, Ray Dentlinger, Lori Wickman, Dennis Bigelow, and Debra Oelmann.

The Secretary read the minutes of the 2013 Annual Meeting. It was moved by Phil Thyer, seconded by Robert Olson, to accept the minutes as read. Motion carried.

The Treasurer's report for the year and a summary of the state shoot were presented. There were 391 annual memberships issued in 2014 compared to 422 in 2013. The life memberships issued in 2014 were 4 compared to 8 in 2013. Grand total life memberships issued are 807. The daily fees for 2014 were \$6,669.00 compared to \$4,401.32 in 2013. State shoot entries thru Saturday are 4,366 from 4,122 in 2013, up 244 shooters or 6%. Cash assets as of July 21, 2014, were \$97,436.93 compared to \$85,854.64 on July 20, 2013.

The High School Shoot was held Friday, May 30th and had 1,291 shooters who shot 100 targets. The SCTP Shoot was held Saturday, May 31st and Sunday, June 1st. On Saturday 1,014 shooters shot 100 targets (compared to 734 who shot 200 targets in 2013) and on Sunday 399 shooters shot 100 targets (compared to 308 shooters who shot 200 targets in 2013). Total targets shot, including practice, were 297,852 (compared to 332,475 in 2013). Our estimated profit from the High School Shoot was approx. \$28,500. Louis Segebart moved, Tim Gerdes seconded, the financial report is accepted. Motion carried.

Election of President:

Pat Lyman nominated Denny Dozark as President, seconded by Randy Grilz. Mark Scholl moved nominations cease, seconded by Marlin Cromwell, motion carried. Denny Dozark was declared President.

Election of ATA Delegate:

Tim Gerdes nominated Lori Wickman as ATA Delegate, seconded by Marlin Cromwell. Dan Schlicher nominated Hal Myers as ATA Delegate, seconded by R. G. Prucha. Mark Scholl moved nominations cease, seconded by Louis Segebart. Hal Myers and Lori Wickman then addressed the group. Dennis Dozark also stated the duties of the ATA Delegate. After the vote was taken by paper ballot, Hal Myers was declared ATA Delegate. Mark Scholl moved the ballots be destroyed, seconded by R. G. Prucha.

Election of ATA Alternate Delegate:

Beverly Domanicki nominated Dennis Bigelow as 1st ATA Alternate Delegate, seconded by Kathy Johnson. Hal Myers moved nominations cease, seconded by Steve Manary. Dennis Bigelow was declared 1st ATA Alternate Delegate.

Hal Myers nominated Pat Lyman as 2nd ATA Alternate Delegate, seconded by Phil Thyer. Louis Segebart moved nominations cease, seconded by Robert Olson. Pat Lyman was declared 2nd ATA Alternate Delegate.

Kenneth Grell stated that he was going to contribute \$200 added money for the doubles championship at the 2015 Iowa state shoot for category shooters. This was matched by Bob Doerres and Dennis Bigelow for a total of \$600 added money.

Denny Dozark commented on the high school shoot. At the zone shoots this year, Kevin Hartwig was re-elected NE Zone Director and Dave Wickman was re-elected NE Alternate Zone Director. Jon Peterson was re-elected SW Zone Director along with Doug Brower as SW Alternate Zone Director. Denny thanked Justin Venner for purchasing the trophies for the state shoot. Denny thanked all the state shoot sponsors this year which included Crow Shooting Supply, White Flyer, Pioneer Hi-Bred International Inc., Farmers National Company and Cedar Falls Gun Club. Denny updated the membership on the water system which was installed and an update on the lead mining.

Mark Scholl commented on the Friday Youth Shoot which had 26 shooters. Denny stated that the scholarship program has been eliminated due to lack of interest. Denny also recognized Bob Kisner who has shot 200,000 singles in his career.

A motion was made by Marlin Cromwell that the meeting adjourn, seconded by Pat Lyman. Meeting adjourned at 8:55 am.
